The Typedepot Demo Font End User License Agreement

Version 1 - May 08, 2018.

By downloading, installing and/or embedding font software ("Font") offered by Typedepot or its distributors, you ("Licensee") agree to be bound by the following terms and conditions of this End User Licensing Agreement ("EULA"). If You do not agree to all of the terms and conditions of this Agreement, do not complete the installation of the Fonts.

1. Right Granted

Typedepot grants Licensee a worldwide, non-exclusive and non-transferrable license to, for internal testing purposes or student projects only, use the Font to create graphics, link the Webfont to webpages using the @font-face selector in CSS files, and embed the Font into applications or ebooks.

2. Requirements and Restrictions

Licensee agrees to abide by the following requirements and restrictions:

- a. Licensee may not create products with the Font to be used commercially, or impersonally. Products created with the Font are for testing and evaluation purposes only.
- b. Licensee may not embed the fonts in any products or webpages that are publicly accessible without prior written consent from Typedepot.

3. Provision to Third Parties

Licensee may NOT provide the Font to a producer, publisher or other agent who is working on behalf of the Licensee except by embedding or linking in accordance with this EULA.

4. Term

This EULA grants the rights set forth in Paragraph 1 for a period of 30 days after the purchase date on the receipt unless and until the EULA terminates under Paragraph 8.

5. Other Usage

This EULA is a "demo license". Licenses for Desktop use, @font-face embedding, computer applications and games, installable interactive books, software, mobile applications and games, Ebooks and Epubs, product creation websites, website template distribution, website templates, and other uses not allowed by this Agreement may be available for an additional fee. 6. Modifications

Licensee may not modify the Font or create derivative works based upon the Font without prior written consent from Typedepot EXCEPT THAT Licensee may generate files necessary for embedding or linking in accordance with this EULA.

7. Copyright

The Font is protected by copyright law. Typedepot is the sole, exclusive owner of all intellectual property rights, including rights under copyright and trademark law. Licensee agrees not to use the Font in any manner that infringes the intellectual property rights of Typedepot or violates the terms of this EULA. Licensee will be held legally responsible, and indemnifies Typedepot, for any infringements on the foundry's rights caused by failure to abide by the terms of this EULA.

8. Termination

This EULA is effective until terminated. If Licensee fails to comply with any term of this EULA, Typedepot may terminate the EULA with 30 days notice. This EULA will terminate automatically 30 days after the issuance of such notice.

9. Disclaimer and Limited Warranty

Typedepot warrants the Product to be free from defects in materials and workmanship under normal use for a period of twenty one (21) days from the date of delivery as shown on Receipt. Typedepot's entire liability, and Licensee's exclusive remedy, for a defective product shall be, at Typedepot's election, either (1) return of purchase price or (2) replacement of any such product that is returned to Typedepot with a copy of the Receipt. Typedepot shall have no responsibility to replace the product or refund the purchase price if failure results from accident, abuse or mis-application, or if any product is lost or damaged due to theft, fire, or negligence. Any replacement product will be warranted for twenty one (21) days. This warranty gives Licensee specific legal rights. Licensee may have other rights, which vary from state to state.

EXCEPT AS EXPRESSLY PROVIDED ABOVE, THE PRODUCT, IS PROVIDED "AS IS". TYPEDEPOT MAKES NO WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
